## RULES

PRIZE FUND \$8.00 LINEAGE \$8.00 TOURNAMENT EXPENSES \$6.00 TOTAL PER PERSON \$22.00 (TOTAL FEE'S \$71.00 PER PERSON TO BOWL DOUBLES, SINGLES, TEAM AND ALL EVENTS)

- 1. The purpose of the Tournament is to foster and encourage the spirit of good fellowship and fair play among those who desire to participate in the competitive sport of ten pins and to participate in the Annual Tournament. The Tournament is USBC certified.
- 2. Tournament will be conducted under the Rules & Regulations of the USBC. All participants must have a current USBC card. Team Captains are responsible for verifying all averages CERTIFIED BY THEIR USBC ASSOCIATION. It shall be each bowler's responsibility to verify the accuracy of average whether submitted by the bowler, their Team Captain, or others. Failure to use the correct average can disqualify score if submitted average is lower than correct average if is higher than the correct average.
- 3. Handicaps for Tournament shall be based on 2018/2019 highest USBC average of 21 games or more; if none, than USBC average of 21 games or more as of January 1, 2021. If a bowler has a January 1, 2021 average of 21 games or more that is 10 pins or more higher than the prior season's average, the January 1, 2021 average must be used. Any entrant at time of bowling who has a current average of 21 games or more that is 10 pins more or higher than previous season's average must use current higher average (Rule 319a-2). Any bowler without an acceptable average may enter the Tournament using a 225 scratch average for men or 180 scratch average for women.
- 4. All bowlers who have qualified for a prize of \$600.00 or more in any event in a Tournament within the previous 12 month period must report actual score, position and amount won for possible re-rating prior to bowling (Rule 319(d)). If a bowler has been re-rated or disqualified by other tournament or USBC Associations within the past year, the bowler must report it to the Tournament Director prior to bowling. Failure to comply with these provisions will result in disqualification and forfeiture of all entry fees and prize winnings. All bowlers should acquaint themselves with the full contents of Rule 319(e) that applies during this Tournament. Any violation of any part of this entire rule will result in disqualification and forfeiture of entry fees. THERE WILL BE NO EXCEPTIONS! RIGHTS RESERVED TO ACCEPT, RE-RATE, OR REJECT FOR ANY REASON ANY BOWLER PRIOR TO BOWLING. A copy of the playing rules will be available at the Tournament. Any bowler qualifying for a prize of \$600 will be required to complete a W-9 before check will be issued.
- 5. Handicaps will be 90 percent between bowler's average and 240.
- 6. No more than two substitutes will be allowed in the 5-player team event in the Doubles event, one of the players entered must bowl and names of both players must be given as entries with the word "Partner" will not be accepted. Team, Doubles, and Singles will bowl in the order as signed up. Any substitution during a game or series will be made in accordance with Rule 324(b). Any player or team arriving late shall begin with the score counting beginning with frame then being bowled. NO BLIND SCORE. Bowlers must bowl on the same time their team bowls. NO UNREASONABLE DELAY. The Tournament Officials shall allow no unreasonable delay in the progress of any game. Should any member or team participating in the Tournament refuse to proceed with game after being directed to do so by the proper authorities, such games or series shall be declared forfeited.
- 7. The ratio for prize distribution will not be more than one winner out of every 10 entrants in each event, except All Events which is one out of 20. An individual must bowl in all three events to be eligible for All Events.
- 8. Bowlers may enter multiple Doubles (lane permitting) and may only bowl once in singles. An individual will be permitted to bowl team events more than once in the prize list for position standings (Rule 317). A bowler's first appearance in Team Event shall count towards the bowler's All Events score.
- 9. Any protest involving eligibility or playing rules shall be made in writing to a Tournament Official before tournament prizes are paid
- 10. PLEASE ENDEAVOR TO MAIL ENTRIES EARLY. LATE ENTRIES ARE SCHEDULED IN LATE SQUADS. WHEN WEEKEND BECOMES FULL, YOU WILL AUTOMATICALLY BE SWITCHED

  TO ANOTHER WEEKEND OR MONDAY-TUESDAY SQUAD TIMES. NO ENTRIES WILL BE RETURNED AFTER CLOSING DATE. Confirmation will be emailed or mailed as soon as possible after receipt of entry.
- 11. Any bowler who does not appear and is not ready to bowl when scheduled SHALL FORFEIT ALL ENTRY FEES AND PRIZE WINNINGS.
- 12. In case of postponement requests, changes may be made providing scheduled permits and the Tournament Management is notified before Tournament play begins.
- 13. NO ENTRY FEES WILL BE RETURNED AFTER APRIL 8, 2021. Walkins permitted upon lane availability. All entries must be in and paid for by April 1, 2021.
